# PUBLIC ELECTIONS (EXPENDITURE AND DONATIONS) (JERSEY) LAW 2014

Third party's written declaration of election expenses and donations relating to the election held on 22 June 2022 in accordance with Article 12 of the Public Elections (Expenditure and Donations) (Jersey) Law 2014 ("the Law").

This declaration must be completed and returned to the Jersey Electoral Authority (via the Judicial Greffe's office at the Royal Court Building, Royal Square, St Helier) no later than 20 July 2022 — failure to do so without reasonable excuse constitutes an offence.
