## Election Day: Wednesday 15 October 2014

The Privileges and Procedures Committee is required to publish the background and policies of the candidates in the forthcoming elections in accordance with the provisions of the Public Elections (Expenditure and Donations) (Jersey) Law 2014. **The information about each candidate is provided by each of the candidates themselves and the views expressed are those of the candidates and not of the Privileges and Procedures Committee.**

## Election and Referendum 2014

The elected members of the States of Jersey are Senators, Connétables and Deputies.

On 15 October 2014, we will elect 8 Senators, 1 Parish Connétable (St. Mary) and 23 Deputies for a term of office of 3½ years (11 Parish Connétables and 6 Deputies have already been elected unopposed).

We will also vote in a referendum on whether the Connétables should remain as members of the States Assembly as an automatic right.

There will be a separate ballot paper for each election and a ballot paper for the referendum.

### Senators

There are 8 vacancies for Senator in this election. Senators have an Island-wide mandate. If you are registered to vote, you can vote in the Senators election.

The ballot paper for Senators will be white.

### Connétables

There is 1 remaining vacancy for Connétable in this election, in St. Mary. The Connétable is the administrative head of the Parish. You can vote for the Connétable if you are registered to vote in St. Mary. The Connétables in the other 11 Parishes have already been elected uncontested.

The ballot paper for the Connétables will be blue.

### Deputies

There are 23 remaining vacancies for Deputies in this election (6 Deputies have already been elected unopposed). Deputies are elected in 17 districts corresponding to Parish boundaries or administrative districts within the Parish. You can vote for the Deputy or Deputies who are standing in the district where you are registered to vote, unless a candidate or candidates have already been elected uncontested.

The ballot paper for Deputies will be green.

### Referendum

The question in the referendum will be:

**“ Should the Constables remain as members of the States as an automatic right? ”**

You can vote either ‘YES’ or ‘NO’ in the referendum.

The ballot paper for the referendum will be yellow.

## Voting at a polling station or pre-poll voting station

### Voting before Election Day

If you are registered to vote you can vote before Election Day at:

### Voting on Election Day

You can vote on Election Day at your Parish or district polling station, which will be open on Wednesday 15 October from 8am to 8pm.

\* There is one election in the Districts of St Helier No. 3 and No. 4. Voters in those districts cast their votes at different polling stations on Election Day, depending on what district they live in.

If you live in St. Helier, St. Saviour or St. Brelade and you are not sure which district polling station to attend, you can find out on [www.vote.je](http://www.vote.je) or by contacting your Parish Hall.

## Casting your votes at a polling station

When you arrive at the polling station or pre-poll voting station you will be asked for your name. You should have some identification with you such as a driving licence or passport in case it is needed. You will then be asked which of the elections you wish to vote in (Senators and/or Deputies' elections and/or Connétables if you live in St. Mary) and whether you want to vote in the referendum.

If you are going to vote in all the elections and the referendum, you will receive a separate ballot paper for each to complete. If you decide you only wish to vote in one election, for example, then you will only be given one ballot paper.

You will then go to the voting booth to cast your vote by putting an 'x' beside the name(s) of your preferred candidate(s) or beside the word 'Yes' or 'No' on the referendum ballot paper.

## Voting by post

If you will be out of the Island on Election Day you can apply to vote by post.

Postal voting forms can be downloaded from [www.vote.je](http://www.vote.je) or requested from your Parish Hall. You must return your application form by noon on Wednesday 8 October 2014 to:

When the Judicial Greffe receives your application, they will send you everything that you need to cast your vote:

1. You will receive your ballot papers and a ballot paper envelope. Mark an 'x' in the box alongside the name(s) of your preferred candidate(s) and your preferred option in the referendum then fold the ballot papers and put them inside the ballot paper envelope.
2. Fill out and sign the declaration of identity form.
3. Put the ballot paper envelope and the declaration of identity form inside the return envelope and post it back to the Judicial Greffe, to be received no later than noon on 15 October 2014.

## Voting if you are sick or disabled

If you know you will not be well enough to go to a polling station to vote then you can arrange to vote in advance by completing an application form for a pre-poll home visit. Application forms can be downloaded from [www.vote.je](http://www.vote.je) or requested from your Parish Hall. Please return your completed application form for a pre-poll home visit by Friday 10 October to:

If you fall ill on 15 October 2014 and cannot make it to your polling station, please contact your Parish Hall as soon as possible and they will send an official to you to take your vote.

## Completing the ballot paper

The ballot papers will be different colours:

- Senators** - white
- Connétables** - blue
- Deputies** - green
- Referendum** - yellow

The number of candidates you may vote for depends on what election you are voting in.

**Senators:** You can vote for up to 8 candidates (see pages 6-15)


**Connétables:** You can vote for 1 candidate if you live in St. Mary (see pages 43-44)

**Deputies:** You can vote for up to the total number of vacancies in your district unless candidates have already been elected unopposed (see your appropriate Parish/District pages)

**Referendum:** You can vote either 'YES' or 'NO' (see pages 58-59)



## Referendum 2014

On 15 October 2014 there will be a referendum on the future membership of the States Assembly. The question on the ballot paper will be:

**“Should the Constables remain as members of the States as an automatic right?”**

Yes  No

### If you vote ‘Yes’

- **You will be voting to keep the automatic right of the Connétables (Constables) to become members of the States when they are elected by their Parish.**

This means that a Connétable who has been elected by their Parish will automatically become a States member.

### If you vote ‘No’

- **You will be voting to remove the automatic right of the Connétables (Constables) to become members of the States when they are elected by their Parish.**

This means that a Connétable who has been elected by their Parish will need to stand for election if they also want to become a States member.

## Who are the Connétables?

The Connétables (Constables) are members of the States by virtue of their office. Connétables are known to have been members of the States Assembly since before the first minutes of meetings of the States were recorded in the 1500’s.

There are 12 Connétables, one per Parish. The Connétable is the elected head of the Parish. Parishes deliver a number of functions such as the issue of licences and permits, and perform a number of shared functions with the States of Jersey, such as the maintenance of the roads. The Connétables represent the Parishes in the States Assembly.

## How to vote in the referendum

If you are registered to vote, then you can vote in the referendum. Details of how to vote are on page 3.

## What happens after the referendum?

If the majority vote in the referendum on 15 October 2014 is “Yes” then there will be no change to the current position whereby Connétables are automatically appointed as members of the States.

If the majority vote in the referendum on 15 October 2014 is “No” then the States will need to consider what changes should be made to the composition and election of the States Assembly.

# Should the Constables remain as members of the States as an automatic right?

**On Wednesday 15 October, you can vote either ‘YES’ or ‘NO’ to the above question in the referendum.**

## Senators

## Philip Bailhache - Standing for Senator

### CONSTITUTIONAL REFORMS (Making the States work better)

Experience has shown that achieving sufficient agreement among States members to enact changes is very difficult. Yet there is still an urgent need for reform. The electoral system is unfair and unbalanced. Some electors elect 4 deputies, and others only one. In one electoral district a deputy represents 1340 voters; in another, a deputy represents 4010 voters, about 3 times as many. Work must continue to secure a majority for sensible reform. Most importantly, the number of members should be reduced. It is not sensible to have more States members than are needed.

A fairer system will encourage a higher voter turn-out.

### STRENGTHENING THE ECONOMY

The financial services industry is the major plank of our economy, providing the bulk of tax revenues and much employment, and must be supported. At the same time it is vital to create an environment in which fresh enterprises can flourish and create new employment opportunities; red tape and obstacles to business should as far as possible be eliminated. Agriculture and tourism are also very important elements of the economy, and need our support. Everyone in the community should share the fruits of economic success.

### TAXATION

The only justification that a government has for taking money from the public is to fund essential public services. Jersey should continue as a low tax economy, with income tax remaining at

20%, which is now a symbol of our financial stability. As soon as the economy permits, some allowances should be restored to ease the burden on "middle" Jersey. No one likes paying tax, but GST is an effective and reliable way to raise revenue. It should continue to be broad, simple and low; it should not be permitted to rise above 5% for the foreseeable future. Protection for those on lower incomes should be achieved, as now, through the income support system.

### THE PUBLIC AND PRIVATE SECTORS

The government of Jersey must live within its means. Not all departments have adapted to the more stringent times in which we live. Certain important services can best be provided by the state, but the government should try to identify areas where services can be provided more effectively and cheaply through private enterprise and the voluntary and community sector.

The cost of government must be contained and the public finances balanced.

More individuals should be helped to become homeowners. The government should act to make that dream become a reality for as many young Jersey people as possible.

### RIGHTS AND RESPONSIBILITIES

All citizens should be encouraged to lead independent lives, to develop their talents to the fullest possible extent, and not to be dependent on state benefits. Citizens have rights but also responsibilities to maintain and improve the quality of life in the Island. It is nonetheless the duty of a civilized and caring society to protect vulnerable members of the community, whether they are elderly or sick or otherwise deserving of support.

## Guy de Faye - Standing for Senator

### BACK OFF ON TAX

Jersey suffered during the economic recession and any analysis of the global economy indicates it is not all over yet.

Hardest hit have been low and middle wage earners and I think they need a break, especially as more spending money will help boost the local economy. In addition to adjusting the base income tax thresholds, I would like to see an introductory 10% tax rate.

It is also obvious that raising alcohol prices has had no impact on "problem drinkers", but IS progressively ruining our local hospitality trade and damaging Tourism. GST on alcohol is sufficient.

Jersey voters also need to assess the "stealth taxes" being imposed by our local utilities. I would prefer cheaper charges across the board and end multi-million pound "dividends" paid into Treasury, only to be squandered by the States.

### CUT BACK GOVERNMENT

I was astonished to learn that Jersey now has over 7,000 public employees. How has this happened, when the current deficits demonstrate this is not sustainable?

The answer is that we were promised a "Rolls-Royce civil service" and like most Roll-Royce vehicles - it has become too expensive to run.

To cut back there will be pressure on numbers and salaries which should not fall on non-management staff. In the short term, any pay freezes should start with the highest salaries and work down.

### EDUCATION

For years we have enjoyed some of the highest quality education in the British Isles, but we now discover

that British standards compare poorly internationally. This needs to be addressed urgently.

I also consider that a wider "drop-off envelope" and later class start times for Town based secondary schools could bring a dramatic conclusion to morning traffic congestion.

### HEALTH

I favour a preventative approach, with regular health checks to catch illness early, backed up with first class treatment for those that do fall ill. I would continue with free prescriptions and additionally look at what might be done to improve or subsidise access to dental care.

### HOUSING

I want to help HOME BUYERS by removing the stamp duty levy from purchasers. If anyone is to pay stamp duty, it is the person holding the big cheque – the seller.

### MISTAKES

Firstly, stop building on revenue earning States property. The Gas Place car park used to earn over £300K each year. Now, with

that money lost, the Town Park represents MINUS £400K a year.

### PLENTY MORE

### POPULATION

Jersey must get a grip on population control. The longer we wait, the tougher the measures will have to be. However, a level of immigration must continue for skills that cannot be provided locally.

### RECLAMATION

To protect land space Jersey should consider a new reclamation scheme that could radically improve links to France, offer a 24/7 access yacht marina and "offshore" housing. In due course this could offer a cruise ship berth and additional port facilities.

### RENEWABLE

It is time to initiate action on marine based energy and other renewable energy sources.

- **More money can be spent on sports and leisure facilities and protecting the environment.** With higher GVA a society can devote more resources to sports and leisure facilities and the use of renewable resources and recycling.

• **Investment.** Economic growth will encourage new investment into the local economy and therefore encourages a worthy cycle of economic growth.

**Economic Growth, Population & Immigration** - Economic Growth if properly delivered does not lead to excessive population growth. **Economy** – We are hopefully seeing the end of one of the deepest, darkest recessions that the Island has ever experienced. Whilst tough decisions have had to be made around fiscal policy, when we return to balanced books, the Jersey taxpayer needs to be shielded from any increase in taxes. In my experience the root of these problems can very often be identified, at an early stage, through the education system and I would like to see more engagement and support through schools to let young people know that help is available and that there are solutions to their problems.

**Social Security** – If I am elected, I would like to put myself forward for a Ministry and Social Security

would be my first choice, not least because I spent twelve years working in that Department and understand the inner workings of the benefits system, unemployment assistance, return to work schemes, minimum wage mechanisms, family friendly proposals, the long-term care scheme and discrimination legislation.

It is clear that there are financial pressures on the ring-fenced Social Security Fund and that in the very near future tough decisions may have to be made to preserve the long term future of the Fund. I would want to make sure that any such remedies are necessary and realistic.

refuse to allow a tree house to be built in one person's back garden but allow speculative building to dominate, or encroach upon, treasured beauty spots?

We need sites for housing but the planning laws need to identify what most Islanders wish to preserve, and listen to local communities on matters such as preferred architectural style.

### Do you ever feel it's not worth voting?

No wonder, if you feel that the States has too many politicians who don't listen to you.

The previous referendum, funded by Jersey taxpayers, was flawed but Islanders now have the chance to vote on whether or not they wish the Connétables to remain in the States Assembly.

*I believe States members should listen to the electorate and not dismiss their views out of hand.*

The minimum wage of £6.63 is not a living wage. Low paid workers usually need to claim income support and need supplementation for social security contributions. In this case the taxpayer is subsidising employers. We support a rise in the minimum wage, and will bring forward a proposal for the voluntary introduction of the living wage.

### Zero-hours contracts

There are many full-time jobs where employers issue zero-hours contracts to avoid their obligations. Under these contracts, employees

do not have proper employment protection or secure incomes.

I support the ending of inappropriate zero-hours contracts.

### Taxation

Candidates cannot claim that they will not raise taxes without slashing public services. Efficiency savings alone will not balance the budget. We will oppose any further rises to GST. Taxes should be progressive and the burden should fall on those most able to pay. Income tax is the only fair tax. We propose a higher rate of tax for those on high incomes, and an increase in the contribution from wealthy residents.

### Education

We have a good Education service. The expertise and welfare of our highly trained teaching force should be at the heart of Education policy. For example, the inclusion policy prevents pupils with problems from being marginalised, but makes classroom control more difficult. I would support the adjustment of schools' funding to follow best UK practice.

### Health

Maintaining a healthy population is vital, but many cannot afford GP visits, creating further long-term problems. We propose that the social security cap should be raised to make GP visits affordable for all.

Dentistry is unaffordable for many. We support restoring the funding levels of the Dental Fitness Scheme to promote the dental health of young people, saving money in the long term. The low paid must receive appropriate support.

### Population and housing

We must limit population growth to protect our green spaces, alleviate the pressure on our infrastructure and combat the housing crisis.

I am a skilled communicator, and with the support of Reform Jersey I can make a difference.

## Gerard Baudains - Standing for Deputy in St. Clement

Age 67. Educated at Victoria College, F.E. and Farnborough Technical College. Lived practically all my life in St. Clement apart from a spell in the UK working at Fighting Vehicle Research & Development. Ran my own engineering business 1975 - 2013.

Deputy for St. Clement 1998 - 2008 & 2011 - 2014. Four years in the Executive and nine in Scrutiny. Member of Le Squez Youth Club management committee 1998 to present.

Hobbies: fishing, boating, motor racing, target shooting.

The problems facing Jersey never seem to get resolved, eg reliance on the finance industry (which is coming under increasing pressure) and no proper control over immigration (meaning continually rezoning green fields to house people). The idea immigration will offset an ageing population is economically bankrupt - that's a Ponzi scheme, where the problem simply multiplies until it catastrophically collapses.

The public complain they're not listened to, and they're right.

The Island used to be governed by the States Assembly (where all decisions were made by elected representatives) but now Jersey is governed by a handful of politicians (eleven ministers) with the rest kept at arm's length. Most decisions are now made by civil servants, and democracy has been trampled.

We must return power to the people. I have been trying to achieve that for some time, but to do so requires fundamental changes to our machinery of

government. Unfortunately certain ministers' lust for power, the sycophants who support them and a few others who perceive change as a threat to their self-importance makes progress nigh impossible. Also, as years pass fewer and fewer members are left who experienced Committee government, enabling the above group to convince new members that committees are some sort of hindrance. In which case, why do we have a Public Accounts Committee, a Planning Applications Panel, the Privileges and Procedures Committee (plus any number of boards)? How can replacing seven elected decision-makers with one minister improve democracy?

It's not ministers or back-benchers who hold the balance of power, but those in the middle. If we are to make any progress and return to a government that respects the wishes of the people, the public must be more aware of that group when they vote.

If elected, I promise to represent St Clement and its parishioners as robustly as I have in the past, with especial vigilance regarding any proposed rezoning of more of our fields.

(The 2002 Island Plan proposed rezoning a number of St Clement fields for housing. It was I who brought a (sadly unsuccessful) Amendment to remove those sites from the Built up Zone. This year (2014) I supported our Connétable in his attempt to again remove rezoned sites earmarked for St Clement).

I will also use my political experience to keep pressing for reform of our machinery of government. Only then will we get spending and immigration under control and once again govern the Island as the public would wish.

**The Finance Industry** is vital to our economy, but any tightening of tax laws by other countries is an ever-present danger, and we need to start looking at alternative industries for the Island. We need to review the proposed Finance Quarter on the Esplanade. In the current global financial climate we should not be embarking on such a major capital project.

We need to encourage more diverse use of the Parish Hall as our community centre and fully support all community based projects.

Rates and Property Taxes

I will fight to ensure that the Parish continues to set and collect its

own rate, our Constable, honorary officials, volunteers and staff provide an efficient and effective service to Parishioners.

Ensuring a Future for the Parish

Where possible I would like to see more Public Services undertaken by our Parish administration rather than by the Civil Service in order to benefit from the lower cost and higher quality service that our Parish delivers, funded by the States.

The change from Parish Welfare to Income Support is a perfect example. The cost rose and the quality of service fell. Our 44 community volunteers do a wonderful job in plugging the gap which this change created in our community.

Taxation & Expenditure

No one should pay tax until they have enough to support themselves and their family.

Recent financial results demonstrate that our rate of taxation is sub-optimal.

Recent tax increases have led to falling tax receipts, we need to lower taxation to increase tax revenues. I favour raising the income tax threshold to share the benefit equally.

Many genuine savings are easily achieved. For example, by combining the collection of Social Security and Income tax we would achieve a genuine reduction in government expenditure by removing duplication.

These savings would allow for a significant and much needed increase in the income tax threshold.

Finance Industry

Our finance industry must remain competitive. We must ensure that the regulatory burden placed upon it does not smother it's viability. There are major global changes impending and our government must be ready to react swiftly to anything that arises in order to protect our economy.

As Assistant Minister for Social Security, I have gained knowledge useful when answering numerous questions parishioners have regarding Income Support,

housing issues and the financial implications of family breakup, redundancy and unemployment.

**Long Term Care:** For the past 3 years I have worked hard to produce the Long Term Care Scheme: introduced on July 1 this year. This provides choices for people requiring care; including residential and nursing homes, and most importantly the option of care in peoples' own homes without having to sell their homes to do so. I am proud to have been part of this achievement.

**Discrimination Law:** a massive piece of legislation with which I have been involved; with 'race' as its primary characteristic, to be followed by Sex Discrimination, then Age and Disability Discrimination. I also helped introduce the belated and much needed addition of 'Family Friendly' Law; ie. Maternity and Paternity rights.

We must do more to support the estimated 18,000 Islanders with some form of disability, and

improve their quality of life. I fully support the proposed 'Disability Strategy'.

**Employment:** I am on the Board of the Jersey Employment Trust: established to encourage and find employment for people with disabilities. This organisation consistently strengthens.

I sit on the Housing and Work Advisory Group Board; essentially immigration control. I seek to balance growth in the economy, necessarily involving some immigration, with the unprecedented unemployment levels in recent years and sustaining an ageing population.

This current Government has been concentrated on 'getting people back into work', and Social Security has had major success operating schemes involving employers and jobseekers. 'Back to Work' offers pre-interview training, in-job support and mentoring and to date has found employment for 1,326 people in 2012 and 1,818 in 2013.

**The voluntary sector:** I strongly support this: with a phenomenal voluntary tradition in Jersey of which we should be proud. A shining example is our own Parish Community Support Scheme. This has been incredibly successful, with many other Parishes now following our example.

**Traffic:** The 30mph limit in St. Clement has been well received by most people. More needs to be done; including additional zebra crossings.

**Development:** I'm strongly against further large scale development in St. Clement although I understand the need for more social housing. I voted against the recent proposals for St. Clement and feel States owned sites should be used more.

I understand the lack of faith after the referendum result was overturned by some States members; I was not one of them! I hope that you will take the time to vote.

As a 21 year old female from a working class background, born and raised on the island, I am standing for the position of Deputy in St Helier No1 District because I believe that the States is out of touch with its electors and needs to be modernized. since I had been refused any grant. During my time at college I examined many aspects of life in Jersey, from domestic violence, to the training of army reservists. This included making a documentary on the lack of basic rights for the LGBT community in the island.

The reason I have decided to stand in this year's election is because I have experienced the way the States of Jersey have neglected to treat their own with fairness and respect.

I stand for the rights of all human beings and will fight for equality in all areas including access to education and employment protection. The minimum wage for example is set at a level which produces in-work poverty and barely covers many people's rent. Zero- hours contracts must be carefully regulated to prevent abuse and protect employees from exploitation. If we need to increase taxes in order to protect the standard of our public services,

then we should introduce a higher rate of tax for the really wealthy and not raise GST any further.

I believe that Constables are primarily elected to fulfil a vital role in their parishes. They should not automatically be members of the States, though those who wish to take on a dual role should be able to stand as parish deputies. Each parish should have fair representation based on its population.

Looking back at my manifestos, there are still many issues that need to be addressed, such as sustainable population, GST and parking in St Helier.

I believe Jersey needs regenerating by creating new ways to market our existing products and services, developing new areas of expertise and entering new global markets.

I am committed to working towards a vibrant, safe and pleasant town for residents and visitors alike, and a fair, prosperous, caring and sustainable future.

I am against the Goods and Services Tax but until we find alternative revenue GST will probably need to stay. I will rigorously resist GST increasing above 5%, and remove it from essential items like food as soon as possible.

The lack of parking in St Helier is causing parking difficulties for visitors and residents of St Helier

and needs urgent attention. The Gas Works site would be an ideal site for an underground car park with extension of the Millennium Town Park to St Saviours Road.

We should be helping to make the dream of homeownership become a reality for as many as possible. With greater access to affordable accommodation; this may involve developing further home ownership schemes to help get people onto the housing ladder. The problem is not only for those at the bottom of the property ladder, but also for the older population who would prefer various forms of sheltered housing. We should be looking at increasing the provision of sheltered housing which would free up much-needed housing for young families.

We need to introduce work permits to protect local employment opportunities and help maintain a Sustainable Population. Past and present failures to meet policy

guidelines have been the result of insufficient controls and measures.

However, population control should not be exercised in a way that jeopardised the health of our economy on which the island's social policies depend.

My politics are not about left v right; I believe effective politicians need to work together for the benefit of St Helier and the Island no matter what their political persuasion. If elected, parishioners of St Helier will have someone who has the experience and knowledge to deal with the complex issues our States Members are expected to deal with.

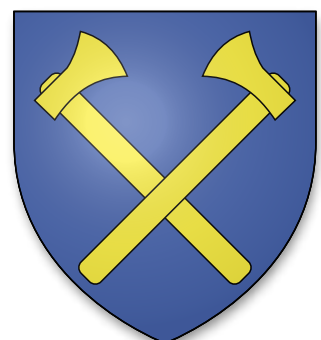

For the past year, I have been Acting Chair of the Health, Social Security and Housing Scrutiny Panel. Our work involved questioning and holding to account the relevant Ministers and listening and taking evidence from the public, professionals and other interested parties.

### Health

I recently co-authored and chaired a scrutiny panel report into the proposals for a dual site option about locating the hospital on two separate sites. The report asks challenging questions and raises serious concerns. ### Children and Social Services

### Cost of living; raising minimum wage

Minimum wage is currently 13p per hour more than that in the UK. This equates to less than 2% uplift which is not comparable to our cost of living being, on average, at least 20% more.

An individual working full time on minimum wage cannot afford accommodation, food and other necessary living expenses in Jersey so relies on Income Support to fill the gap. Taxpayers' money is therefore used to subsidise employers and landlords.

The minimum wage must be raised to reflect the cost of living in Jersey.

I will be voting to increase this and to introduce a 'living wage' of around £9 per hour.

### Fair taxation

The £95m deficit created by the Treasury Minister will have to be funded somehow. GST has hit the poorest badly and '20 means 20' has put the squeeze on middle earners. Only the wealthy who can most afford it, can and should, contribute a greater share.

I will oppose any further rise in GST  
**Population control**

The interim population policy will see numbers rise to 120,000 and the new hospital is being built to cater for 150,000. The lower figure will need an additional 4,000 homes to be built. Where will they go? Not on green fields but crammed into the already overpopulated St Helier.

More sustainable targets need to be set and stuck to

### Maternity Leave

The States recently rejected a proposal to introduce six months maternity leave, to be paid from the mother's Social Security contributions, deciding that two weeks was sufficient.

Six months is in line with the rest of the Western world.

I will bring back this proposal for 26 weeks ensuring that new mothers are not forced to resign from their jobs when they wish to start a family.

### Affordable childcare

Childcare costs are high in Jersey meaning that many mothers wishing to return to work are often prohibited from doing so.

I intend to work to bring about States funded means-tested childcare facilities.

### Part-time work

Policies need to be put into place that are family friendly. The UK continues to implement legislation ensuring that those who can only work part-time have full access to the employment market.

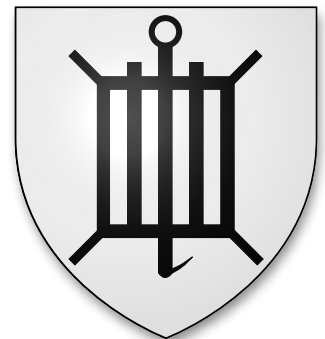

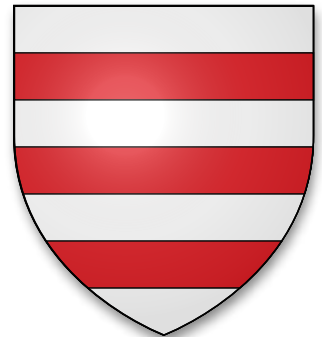

savings thermal efficiency and maintenance, notably replacement windows.

St Mary still lacks basic infrastructure in some large areas of the Parish - main drainage and mains water is non-existent to many properties people who have to rely on spring water for drinking constantly face a pollution problem.

Political and Constitutional reform and any decision to alter our present structure should be discussed with Parishioners at a Parish Assembly - taking propositions to the States to alter our Parish system and boundary by amalgamating St. Mary with another Parish for voting purposes should not be done without Parishioners' approval - if at all.

I have been active within the States having been elected to the States Employment Board at the start of my term and since being made a member of the Housing and Immigration and

also Environment Scrutiny panels. Within the Parish I have been instrumental in bringing about the 20 mph speed restrictions along Rue des Buttes - through what was nothing more than a motorway to those residents who had to live in constant danger of speeding traffic. Subsequently the traffic calming project which is to be implemented by Transport and Technical Services should make St. Mary a more pleasant experience for everyone when completed. **PROPERTY TAX REVIEW:** A Green Paper has been published on Jersey's Property Tax System. One matter addressed is possible amendment to the present rates system and, if elected, I would then expect to be involved at Parish level so as to better represent your views in the States.

**STATES EXPENDITURE:** I have reviewed a number of Reports of the Comptroller & Auditor General in the context of seeking to identify where savings can be

made in States expenditure. I am determined that, where ongoing shortcomings are shown, these should be more fully addressed so as to achieve savings.

**FINANCE INDUSTRY:** The finance sector continues to be the bedrock of the Island's economy, employing over 12,000 people and generating over 40% of our economic activity. It is imperative that States Members understand its ongoing concerns and requirements so as to maintain the island's position. I consider my own background makes me ideally placed to take an active role in this area; equally, I appreciate the dangers of placing reliance on one sector and of the need to promote other industries.

**AGRICULTURE:** Agricultural land occupies approximately 57% of the island's area and the industry remains an integral part of our way of life. The main crop in terms of monetary value is potatoes and, with the two main

producers now being owned by non-Jersey companies, it remains to be seen whether this absence of local control has adverse consequences.

**TOURISM:** The number of 'staying leisure visitors' appears to be on the decrease and measures need to be introduced to reverse this trend. Provision of more 'all weather' facilities (and the use of Fort Regent in this connection) needs to be considered together with greater efforts to attract 'Sports Tourism.'

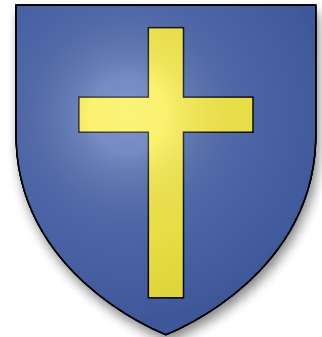

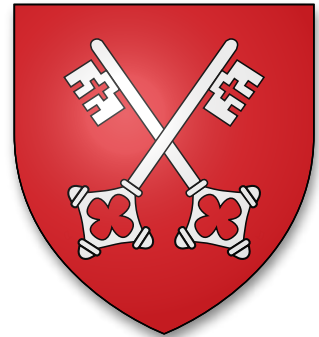

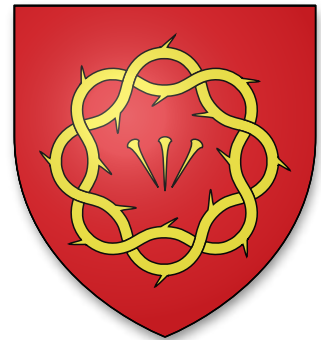

I have published a long-term energy plan for Jersey and worked with the Health Minister to improve air quality. I have encouraged local organisations to help protect the environment through the innovative Eco-Active scheme. Pensioners continue to receive insulation grants which reduce their heating costs and I have

expanded the scheme to include charities.

Over the last three years, I have made significant progress in improving the service the Department provides to the public. Following the results of a public consultation, I have gained approval for a new simpler system of planning appeals.

### **Population**

Looking forward, one of our biggest challenges is the continuing growth in the population. We must take firm action to limit the number of people living in Jersey. I am committed to improving education and training opportunities so that we are less reliant on imported workers.

### **Public spending**

Public spending must be controlled. We will need to take difficult decisions over the next few years as we recover from recession. Jersey's prosperity is based on low tax rates and we must concentrate public spending

on key areas such as health where costs are growing. Local businesses should be encouraged to provide services such as leisure facilities and car parking.

Since 2011, the Environment Department has helped to limit public spending by achieving a significant budget cut. We must keep the pressure up - all departments will need to work more efficiently in the future.

I support moves to diversify the economy, including developing digital businesses, harnessing renewable energy, strengthening the rural economy and encouraging innovative building techniques.

### **Conclusion**

I have always expressed my views directly and taken an independent line on policy issues. If re-elected, I will continue to use my position to ensure that the long-term future of Jersey is secure and that the needs of local parishioners are fully represented.

It has been a privilege to serve as a Deputy in St Saviour District no1 where I live and am part of the community.

My family has been in Jersey since the 1700s. I have a joint social sciences degree from Plymouth University.

Since election I have been Chairman of the Education and Home Affairs Scrutiny Panel, Vice-Chairman of the Economic Affairs Scrutiny Panel, a member of the Chairman's Committee and Planning Applications Panel. I am Chairman of the Privileges and Procedures Committee ("PPC").

PPC changed the Elections Law simplifying elections and enabling more of the electorate to vote.

We changed the standing orders of the States Assembly making its workings more efficient and flexible. We attempted to give the public their say on the Clothier Report but unfortunately the States Assembly decided upon the forthcoming referendum.

### Planning Applications Panel

When reviewing applications I seriously consider the impact on the community and am strict in safeguarding our green zones. I believe that applications should be in keeping with the character of the area in accordance with the Island Plan. I strenuously opposed development of the Longueville Nursery site which remains a green zone.

### Scrutiny

I chaired the Education and Home Affairs Scrutiny Panel and as a result extra provision for children with severe autism was created.

In co-operation with the Chairmen of the scrutiny panels the 3 year spending plan was reviewed and we advised that the predicted forecasts would result in a deficit which is now £95 million. This should have been avoided had the States supported

our amendments to reduce public expenditure.

### Road safety

I campaigned for crossings on Longueville and Bagot Road. Funding has been set aside for this project for 2015.

### Local Schools

I assist local schools with their citizenship programme and attend their events regularly.

### States Assembly

Representing my constituency is a great responsibility which is reflected in my 100% voting record.

### States Funding

I am strongly opposed to GST and continue to fight against any increases.

I advocate lifting the Social Security ceiling on contributions as payments are not proportional, having a greater impact on low and middle income earners.

### E-Government

I support the digital integration of States facilities to create greater efficiencies and cost-saving across all States Departments.

### Fort Regent

I support investment in Fort Regent, particularly in resolving the access issues and encouraging a greater use of the site.

### Migration

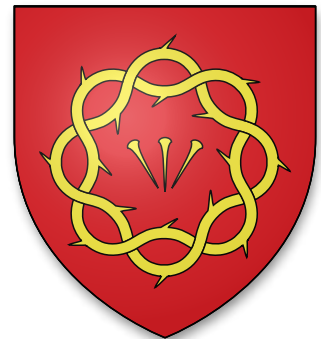

We are starving our Island of home grown talent. We must seek ways to assist them to stay and enjoy a fair standard of living.

### Transport

If re-elected I would continue my campaign to restart the Hoppa Bus service and improve public transport.

I have installed many bus shelters and improved pathways., I was instrumental in the re-introduction of the Double Decker Buses.

### The Future

States spending must be better managed, prioritised and where necessary cut.

We cannot live beyond our means.

We must stop focusing on the problems and start focusing on the solutions.

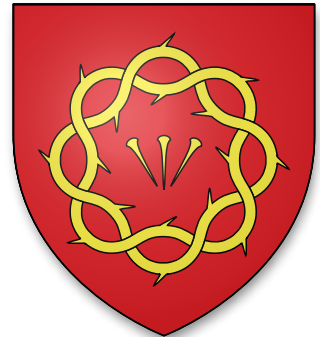

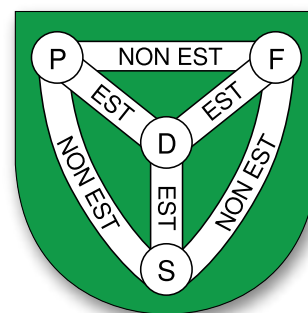

available, through Parish Hall Surgeries, to address the concerns and problems of all parishioners. During this time I have been closely involved in all walks of Parish life, including Trinity Primary School, the Battle of Flowers, as well as being President of Trinity Youth Club, of which I was a founder member.

#### Efficiency

The loss of the Constables will weaken opposition to the current proposals for a centralised property tax. This proposal will cost Islanders more than the current rates system, and be set by the Treasury Minister, not Parishioners.

Parish Rates have remained steady for 10 years. Without an effective Parish Administration bureaucracy will increase, stifling business in Jersey, and increasing the burden on the individual Ratepayer.

If the Constables are removed from the States, they will either have to be paid by their Parishes or not at all. This creates an imbalance and without pay the only people who will stand will be those with the time and money to afford it. It also risks destabilising the whole honorary system should one office holder receive remuneration and the others not.

Ask yourself how effective the administration of your Parish is compared with the States of Jersey, and would you want to remove this efficiency from your Government and Assembly?

#### Community

Through their political role, the Constables can interact with Parishioners and work as part of a support network. The loss of the Constables in the States will undoubtedly lead to a significant weakening of the Parish system – as has been the case in Guernsey for many years.

Constables have been identified as the future for ‘e-Government’ interaction as well as care and the community. This cannot happen if they are not in the States Assembly.

Through the Parish Assembly, and being available at the Parish Hall, the Constable is uniquely placed to be able to understand the concerns of their parishioners. These concerns are taken to the States Assembly directly, through the political role of the Constable. This cannot be replaced.

#### Accountability

The Constables are continually accountable to the Parishioners through the Parish Assembly as well as the ballot box. No other type of States Member is. Parishioners, by the ancient law of Requête can force a Parish Assembly to be called.

Most Deputies do not represent the Parishes in the States. They are elected in their own districts, on the basis of their political views. Each Parish, as a corporate body, is represented in the States by its Constable similar to the way each Department is represented by its Minister.

The removal of the Constables has the potential to de-stabilise Jersey’s Government. The Finance Industry requires confidence in government. Radical changes in the structure of government could damage confidence at a time of economic uncertainty.

There is a suggestion that Constables have a “block vote”. While they may vote the same way, they do so as individuals bringing Parish concerns to the assembly. Statistics show that Senators vote the same way as Constables do, but this goes unremarked. It is worth noting that a Party System would be one in which Party members had to vote the same way and take the agreed Party line. That would be a real “block vote”.

#### Reform

Constables have proven they are reforming States Members. They led the way towards a single election day, a four year term and spring elections. They also removed their own policing powers. Without them reform becomes more difficult to achieve.

The retention of the Constables IS compliant with the Venice Commission, which makes allowances for different jurisdictions: “The geographical criterion and administrative, or possibly even historical, boundaries may be taken into consideration.” Our Parish boundaries are both administrative and historical and thus meet these requirements.

## Referendum “NO” campaign

*“ Should the Constables remain as members of the States as an automatic right? ”*

is the Referendum Question for 15 October 2014.

You are invited to answer yes or no. We say choose “NO” on the ballot paper.

**The set question is not perfect.** There is no scope to discuss many related issues – such as the under-representation of some Parishes in the States - but it is important that the voting public expresses the NO answer in favour of planned, future change.

**12 non-elected Jurats** and **12 Rectors** used to serve in the States but they have been removed since 1948 (apart from the Dean) to be replaced by more democratically chosen and paid **Senators (now 8)** and **Deputies (29)**.

This is all part of the inevitable process for change.

Yet the **12 Constables** remain in the States although they are elected to serve their parishes where they must live (St Helier excepted). Traditionally they were male, honorary (unpaid) and only intended to represent voters at Parish level. Only a few men (no women) were entitled to vote for them and the role of the Constables was extended to the States simply because there were no others elected to represent the public.

**Historically** the system of government and administration of justice was so corrupt that it was overthrown on 28 September 1769 during Jersey’s very own peaceful “Revolution”.

The process of democratic change really started then and continues slowly now with this **Referendum** and the first ever **General Election** for States Members that is taking place on the same day.

The time has now come for the **12 Constables** to return to their Parish duties.

Constables currently enjoy payment of about £46,000 per annum from taxpayers and are fighting to retain this - but it is unfair that taxpayers should pay whereas the Constables should be paid solely by the Parishioners who elect them through Parish rates.

Not paying the Constables to serve in the States could amount to a taxpayers’ saving of £600,000 per annum.

Constables could be paid according to the size of their Parish populations or the job could revert to an honorary role in some of the smaller “country” parishes.

If they wish to serve in the States too, Parish Constables should seek election as a Senator or Deputy and if necessary take the payment for each job.

Constables could also serve - in a voluntary capacity - on States’ Scrutiny Panels and Committees as consultants and such-like.

### What if the public says NO...?

If Constables did not have an automatic seat in the States the whole Parish System could be reformed around an improved **Committee of Constables** that is open to the public and meets regularly to discuss matters submitted by Parishioners.

The scope of Parish responsibilities could be extended to include many matters that currently clog up the States Assembly.

Parish Halls could be expanded as centres of information or advice and be much more useful places for all residents and tourists alike....

**Such matters** and many more must be considered in due course but are not within the terms of reference of the Referendum Question as set. This allows only a single word answer. We say that must be NO.

The public are not robots and should be enabled to elect ALL their representatives in a democratic - not automatic - way.

Constables should NOT remain as Members of the States as an automatic right.
