

## Written declaration of reportable donation to a political party

## PUBLIC ELECTIONS (EXPENDITURE AND DONATIONS) (JERSEY) LAW 2014

Written declaration in accordance with Article 13A of the Public Elections (Expenditure and Donations) (Jersey) Law 2014 by a Political Party of reportable donation

**This declaration must be completed and returned to the Jersey Electoral Authority (via the Judicial Greffe's office at the Royal Court Building, Royal Square, St Helier) no later than 4 weeks from the date of receipt of the donation – failure to do so without reasonable excuse constitutes an offence. This is irrespective of whether any candidate endorsed by the political party at an election was elected.**

**Read the footnotes and Law before completing this declaration. Returning a declaration that the person signing knows or believes to be false in a material particular constitutes an offence.**

***Before completing, this form please read the Law.***

(1) The aggregated amount of the donation

*A donation is a "reportable donation" if its amount or value exceeds the threshold amount; or when aggregated with other donations to the political party made by the same donor during the preceding 3 months the amount or value of those donations exceeds the threshold amount.*
